BILLING: We use Member Solutions to handle our tuition. You will see the phrase "**MEMBER'S FEES**" on your statement.

PLEASE NOTE: YOU are responsible for paying your tuition in all situations including incidents of billing company or bank error. Please check your bank statements. Contact us IMMEDIATELY via email with any issues. We will correct errors ASAP.

TUITION & FEES: Tuition increases 3% with cost of living every year. Unsuccessful automatic transaction; \$10 late fee. Returned payments for any reason; \$25.

HOLD CREDITS/TIME FREEZE: We allow two 1-month freezes per year with only 1 falling in the initial 6 month term. Your payments will continue but we will extend your renewal date and credit you the time you (or your child) did not train. This credit is Non-Refundable and the credit may ONLY be used at the end of the term. If you don't use it, it expires. Should you require more hold time, you will need to cancel the account and re-enroll with a new 6 month term and enrollment fees.

MEMBERSHIP AUTO RENEW: Once you have completed your introductory term, your membership becomes month-to-month with 30 days Written Notice to cancel and Hold Credit applies for a hold.

CANCELATION: You may cancel your membership at the end of your 3 or 6 month term (or once you are on month-to-month) by sending **Written Notice 30 days prior** to the end/renewal date.

SCHEDULING: Please stay with your assigned class. Do not switch days/classes without express permission.

DOJO ETTIQUETTE: Do not speak to or coach students on the mat during class for any reason. Only students are allowed on the mats without shoes. Keep your voices down, cell phones, ipads etc QUIET.

Unattended, noisy or otherwise distracting siblings running around will be asked to step outside.

BEHAVIOR: A student may, at any time, be held back in rank, suspended or expelled from the school with no advance notice should the student be: repeatedly disrespectful inside or out of the dojo, lacking care or good judgment with their partner's or their own safety, training under the influence of any sort of drugs or alcohol, exhibiting or talking about dangerous behavior, using techniques taught in class outside the dojo except in self-defense, or anything else that the instructors or administrators feel is grounds for such action. Racist, sexist, homophobic, rape culture talk or other rude discussion is not acceptable in the dojo – and is not considered in line with the teachings of Practical Martial Arts.

DATES CLOSED: Classes run all YEAR-ROUND regardless of local school or university breaks **except** for legal holidays and the dojo will be closed **Christmas Eve through New Year's Day**. Please be sure to check for yearly changes.

MINORS: We are not liable for unsupervised minors left outside of class times. Students may be left during class but must not be here more than 5 minutes before class starting & 5 minutes of class ending.
